ATTICA TOWNSHIP MINUTES OF THE PLANNING COMMISSION May 19, 2016

1. Special Land Use Approval to expand A2Z Storage Unit Use with Outdoor Storage and a Manager's Residence requested by Daniel Marquardt.

Chairman Penzien opened the Public Hearing for A2Z Storage at 7:03 p.m. Surveyor Rick Duthler introduced himself, displayed the site plan for A2Z Storage and stated that he was prepared to answer any Planning Commission members and residents questions. Pearl and Kirk Watson, of 380 North Lake Pleasant Road, asked about the buildings, drainage, trees, lighting and fencing on the site plan. Surveyor Duthler addressed each point on the Rowe Engineering review of the site plan. There was lengthy discussion regarding storm water retention and drainage. 2. Ryan Stoldt Limited Business Use in the AG District:

MOTION by Lemons, seconded by Berry to recommend the Attica Township Board grant Ryan Stoldt's request of a Special Land Use of Agricultural Limited Business to run an auto repair shop from an accessory building at his home on property zoned AG Agricultural and located at 412 South Youngs Road, Attica, MI 48412, subject to an inspection of the shop and review of the spill prevention plan by the Attica Township Fire Chief.
