1. Medical Marijuana: The Attica Township Board has directed the Planning Commission to draft an ordinance to accommodate a Class C medical marijuana grow facility and 1 processor facility for considerate should Attica Township decide to opt in at a future date:

Supervisor Ochadleus explained to the Planning Commission that the township planner, Giffells Webster, drafted a medical marijuana ordinance for the township that can be built on along with Attorney Gildner and directed the Planning Commission to develop an ordinance.

Attorney Gildner stated that there is an existing facility in the township that made a pitch for the use of medical marijuana and explained how the Planning Commission should go about developing a medical marijuana ordinance. There was discussion.

Planning Commission Chairman Penzien read an editorial in the Lapeer County Press against allowing medical marijuana to be grown and expressed that he is personally against allowing the growing and processing of medical marijuana in Attica Township.

Planner Lloyd stated that he will bring beneficial materials regarding the growing and processing of medical marijuana to the June Planning Commission meeting for the members to review.

There was lengthy discussion.

Planner Lloyd reviewed his summary of findings of the application and site plan for Mining Operation, 1200 Lake George Road, LLC.

There was lengthy discussion regarding the need for an adequate impact statement and the items to include in the statement.

The pumping of water on site and off site was discussed. Applicant, Israel Ferrett, stated that the dewatering permit with the DNR expired in 2015. Supervisor Ochadleus communicated to Mr. Ferret that a permit will not be issued allowing the pumping of water off site.

The operating hours, haul route, and setbacks were discussed.
