At a meeting of the Attica Township Board held on November 11th, 2010, at the Attica Township Hall, 4350 Peppermill Road, Attica, Michigan. TREASURER'S REPORT: Treasurer Mason gave the following Treasurer's Report: General Fund Beginning Balance of \$387,681.52 receipts of \$4,466.41; Interest of \$61.80; Distributions of \$60,946.92 for a New Balance of \$333,262.81. Public Safety has \$71,704.74; Fire Millage has \$34,810.67; Fire Department Escrow has \$3,550.00 and there is \$2,256.97 in the Lake George Road Special Assessment account.

<u>POLICE REPORT:</u> Deputy Nick Vandenberg gave the following police report: there were 220 calls in the month of October with 112 of the calls handled by the Township deputies. Deputy Vandenberg reported that car/deer accidents are up in the County and advised citizens to take extra precautions while driving. Supervisor Ochadleus commended the Township Deputies for the excellent job they are doing for the Township.

1. <u>Pension Program:</u>

Supervisor Ochadleus met with representatives of Burnham & Flower and they suggested the Township switch from John Hancock to ING's pension program because they offer a managed account. There was discussion.
