At a meeting of the Attica Township Board held August 13<sup>th</sup>, 2015, at the Attica Township Hall, 4350 Peppermill Road, Attica, Michigan. ## **REVIEW MINUTES:**

The minutes of the July 9<sup>th</sup>, 2015 regular Board meeting were reviewed by the Board; and there being no additions, corrections or deletions;

**TREASURER'S REPORT:** Treasurer Mason gave the following Treasurer's Report: General Fund Beginning Balance of \$445,786.07, receipts of \$76,189.04; Interest of \$39.77; Distributions of \$58,251.73 for a New Balance of \$463,763.15; General Fund CDARS savings account has \$201,602.85. Public Safety has \$71,359.52; Public Safety CDARS Savings account has \$50,400.71; Fire Millage has \$19,300.31; Fire Millage CDARS Savings account has \$50,400.71; Fire Escrow has \$82,059.09; Fire Escrow CDARS Savings account has \$50,400.71.

#### **NEW BUSINESS:**

## 1. Zoning Coordinator Position:

Supervisor Ochadleus discussed how the zoning coordinator's duties have been handled since Zoning Coordinator Bud Fackler's illness. The issue of how the duties will be handled in the future was discussed.

# 2. Long Term Disability Policy:

Supervisor Ochadleus explained that Attica Township does not currently have a long term disability policy therefore Zoning Coordinator Bud Fackler has been receiving full pay and discussed the reasons a policy is needed. Supervisor Ochadleus recommended adopting the attached long term disability policy retroactive to June 1, 2015.

# 9. Public Time:

a) Supervisor Ochadleus summarized how the decision was made to approve the Verizon cell tower that was approved at July's board meeting and stated that the board followed the recommendation of Planner Birchler. Attorney Gildner explained that the township hired Planner Birchler because of his expertise and his advice should be followed in order to avoid a law suit.

b) Resident, Tracy Sparks, of 4436 Imlay City Road, stated that he has an issue with Planner Birchler's analysis of the setbacks for the Verizon cell tower and feels that Birchler's recommendation went against the zoning ordinance.

c) Resident Longoria asked if Tracy Sparks and he could be included in a law suit against the township if Verizon files a suit against the township. Attorney Gildner advised that individuals cannot be codefendants.

# **REVIEWING AND PAYING BILLS:**
