**3. Heenan Drain:** Supervisor Ochadleus gave an update on the status of work on the Heenan Drain along Newark Road. The Lapeer County Drain Commission has done considerable work on the drain. A drain assessment will be assessed on property the Heenan Drain runs through and there will be a day of review for residents at the Lapeer County Drain Commission office on August 22<sup>nd</sup> from 9 a.m.-5 p.m.
