The Planning Commission recommended that the Attica Township Board grant Starr Aggregates a four year mining permit with a four year extension provided they follow the submitted site plan at the four year point and that they follow all of *Clear*zoning®'s recommendations and remedy any concerns noted in Attica Township's annual inspection.

MOTION by Lacey seconded by Herpolsheimer to approve the recommendation of the Planning Commission granting Starr Aggregates a Special Land Use and a four year Mining permit, with a four year extension provided they follow the submitted site plan and all of *Clear*zoning®'s recommendations, with annual inspections by Attica Township. If at the end of the 2015 mining season deficiencies are noted Starr Mining must come before the Township Board to reassess that the site plan and *Clear*zoning®'s recommendations are being followed. Failure to comply will result in censure up to and including revocation of Starr Aggregates Mining Permit and Special Land Use. A roll call vote was taken.
