At a meeting of the Attica Township Board held on August 14<sup>th</sup>, 2014, at the Attica Township Hall, 4350 Peppermill Road, Attica, Michigan. The meeting was called to order at 7 p.m. by Supervisor Ochadleus. PRESENT: Supervisor Al Ochadleus, Clerk Nancy Herpolsheimer, Trustee Phil Madeline and Trustee Richard Lacey. ABSENT: Treasurer Pam Mason. ALSO PRESENT: Attorney Gildner and the sign-in sheet attached.

**MOTION** by Lacey, seconded by Madeline to accept the modified agenda. A vote was taken. Ayes: All; Nays: None. Absent: One (Mason). **MOTION CARRIED.** 

### **REVIEW MINUTES:**

The minutes of the July 10<sup>th</sup>, 2014 regular Board meeting were reviewed by the Board; and there being no additions, corrections or deletions;

**MOTION** by Herpolsheimer, seconded by Madeline to approve the July 10<sup>th</sup>, 2014 regular Board meeting minutes as presented. A vote was taken. Ayes: All. Nays: None. Absent: One (Mason). **MOTION CARRIED.** 

**CORRESPONDENCE:** Supervisor Ochadleus was contacted by a citizen concerning the hazardous waste collection through the Lapeer County MSU Extension that the township participates in. There are many hazardous items that are not accepted. There was discussion regarding whether it is worth the cost of participating with so many items excluded.

TREASURER'S REPORT: Supervisor Ochadleus gave the following Treasurer's Report: General Fund Beginning Balance of \$528,565.36, receipts of \$91,206.58; Interest of \$47.96; Distributions of \$69,598.27 for a New Balance of \$549,861.63; General Fund CDARS savings account has \$201,039.93. Public Safety has \$86,262.46; Public Safety CDARS Savings account has \$50,259.97; Fire Millage has \$65,797.66; Fire Millage CDARS Savings account has \$50,259.97; Fire Escrow has \$79,598.56; Fire Escrow CDARS Savings account has \$50,259.97 and there is \$3,622.74 in the Lake George Road Special Assessment account.

**POLICE REPORT:** Deputy Nick Vandenberg gave the following police report: there were 156 calls in the month of July with 75 of the calls handled by the Township deputies. Average busiest

time of the day was 10 a.m.; busiest day of the week was Wednesday. There were no problems at Attica Days.

1. **Playground Project:** Supervisor Ochadleus reviewed the status of the playground project: the township signed a contract with Superior Play for the playground equipment, the total project will not exceed \$75,000.00 and the project should be completed by mid-September.

1. **Asphalt in Front of the Museum**: There is a drainage problem in front of the museum. The township received a proposal from T.G. Priehs Paving Company to repair the parking lot in front of the museum at a cost of \$2,200.00.

**MOTION** by Lacy seconded by Madeline to accept the proposal of T.G. Priehs Paving Company to repair the asphalt in front of the museum at a cost of \$2,200.00. A roll call vote was taken. 2. **Attica Days:** There was lengthy discussion among the board and Attica Days committee members regarding the 2014 Attica Days and future Attica Days plans.
