PUBLIC HEARING: Public Hearing to Amend the Attica Township Zoning Ordinance to add Section 4.64 Short Term Rentals and to add Local Agent and Short Term Rental under Article 2.2 Definitions. Chairman Penzien opened the public hearing at 7:01 p.m. Chairman Penzien closed the Public Hearing at 7:02 p.m.

OLD BUSINESS:

1. Motion to recommend the Attica Township Board amend the zoning ordinance to regulate short term lakefront vacation rental property:

Planner Habben informed the Planning Commission that the current draft of the zoning ordinance is to regulate short term vacation rental property and is not limited to lakefront vacation rental property. Planner Habben reviewed the draft of the ordinance. Resident Mary Tullio asked about the fees for this type of use. There was discussion.

2. Change the Definitions of buildings to exclude travel trailers on vacant property:

Planner Habben discussed three options for addressing travel trailers and tents on vacant property. There was lengthy discussion.

Attorney Gildner updated the Planning Commission on Israel Ferrett's Special Land Use for 1200 Lake George Road, LLC. Attorney Gildner received a letter from Israel Ferret's attorney stating that Mr. Ferrett's rights are being violated. Mr. Ferrett's attorney also called Attorney Gildner and informed him that Mr. Ferrett wants the conditions on his Special Land Use tweaked. Attorney Gildner requested, per Mr. Ferrett and his attorney's request, that a Public Hearing be scheduled for the August Planning Commission meeting.

MOTION by Berry, seconded by Stockwell to set a Public Hearing for the August 23, 2018 Planning Commission meeting to hear the requested revisions of the Special Land Use for 1200 Lake George Road, LLC. A vote was taken. Ayes: All. Nays: None. Absent: None. **MOTION CARRIED.**
