## **NEW BUSINESS:**

 Discuss zoning amendment to address the use of shipping containers as storage: Planner Habben reviewed the types of shipping containers and presented various ways they could be regulated through the zoning ordinance. There was lengthy discussion. Planner Habben will craft language for the ordinance and have it ready for the Planning Commission to look at at the July Planning Commission meeting.

2. Remove item #6 from Performance Standards under Article 5.0 Site Standards pertaining to noise:

Planner Habben stated that there is currently a police powers ordinance for noise and an ordinance under Article 5.0 Site Standards in Attica's zoning ordinance for noise. Planner Habben explained that this is a conflict of regulations that needs to be made consistent. Planner Habben will draft a consistent ordinance.

3. Time frame for appealing an administrative decision.

Planner Habben discussed the fact that unless there is an ordinance setting a time frame for appealing an administrative decision an applicant may come back years later to appeal the decision. Planner Habben will draft a standard for appealing administrative decisions.
