Planner Habben read 4.29.1 of the zoning ordinance and asked for direction from the Planning Commission regarding changes to the ordinance. Supervisor Ochadleus stated that he met with Road Commission Engineer, Destain Gingell, regarding road classifications. Planner Habben informed the Planning Commission that AG businesses are only allowed in the AG district, which is a majority of the township, and to keep in mind that by striking 4.29.1 all roads will be open to AG business.

MOTION by Madeline seconded by Stockwell to initiate a text amendment to Section 4.29.1 of the Attica Township Zoning Ordinance. A vote was taken. Ayes: All. Nays: None. Absent: None. **MOTION CARRIED.**
