1. Site plan review for Predator Hunter, LLC., located at 166 S. Lake Pleasant Road.

Planner Habben reviewed the revised site plan and determined that because there were no physical changes to the building or expansion on the non-conformity the Planning Commission could waive provisions addressed in the November 9, 2020 review letter. Owner Paul Cianciolo said that 99 percent of his business is conducted online, he has no walk-in customers. He employs one full time and one part time employee. He has applied for a Federal Firearms License in order to special order firearms to match the night vision scopes he presently sells. He does not intend to have an on site showroom. He has conducted business at this location for three years without complaint.

MOTION by Capizzo, seconded by Gierman, to recommend the Township Board approve the requested site plan for Predator Hunter, LLC., located at 166 S. Lake Pleasant based on the following findings of fact: the site plan satisfies the standards for site plan approval. Further, in order to ensure compliance with these standards, the Planning Commission waives provisions from section 6.1.B from the zoning ordinance, addressed in the November 9, 2020 review letter.
