At a meeting of the Attica Township Board held February 9, 2023 at the Attica Township Hall, 4350 Peppermill Road, Attica, Michigan. REVIEW MINUTES:

The minutes of the January 12, 2023, regular Board meeting were reviewed by the Board; and there being no additions, corrections or deletions;

General Fund; CDARS savings account has \$206,925.58; General Fund ICS has \$591,931.70; Public Safety has \$98,528.24 Public Safety ICS has \$5,073.39; Fire Millage has \$207,162.60; Fire Millage CDARS savings account has \$51,731.59; Fire Millage ICS has \$1,055.94; Fire Equipment Millage has \$122,741.48; Fire Escrow has \$2,691.56; Deposited Escrow has \$25,099.84; Covid Funds has \$264,300.26.

1. American Rescue Plan Funding Status:

Supervisor Ochadleus reviewed the projected spending for the American Rescue Plan funds for 2023 and quotes from Michigan Fence Company for the tennis and pickleball courts.

4. Road Commission Contract for 2023-2024:

Supervisor Ochadleus explained to the Board that he needs to order road material now to receive it this spring.

MOTION by Schultz, seconded by Herpolsheimer, to authorize the extension of the Road Commission budget not to exceed \$320,000.00. A roll call vote was taken. Winslow: Aye: Ochadleus: Aye; Schultz: Aye; Herpolsheimer: Aye. Ayes: All; Nays: None. Absent: One (Mason). **MOTION CARRIED**.

5. Revenue Sharing for 2023-2024:

Supervisor Ochadleus reported to the Board that the projected Revenue Sharing for 2023-2024 is \$515,386.00. He also reported that the Township can qualify for more revenue through the CVTRS program.

6. Bazco Oil Holdings, LLC:

Supervisor Ochadleus reported that Bazco Oil Holdings, LLC submitted an application to the Road Commission. There were two pages of requirements that need to be met before the Road Commission would approve the application. The Township has received nothing from Bazco Oil Holdings, LLC.
